Beneficial Owner*

A **beneficial owner** is an individual who ultimately owns or controls (directly or indirectly) the client. Ownership for the purposes of determining a beneficial owner means **owning 25 per cent or more** of the client. As Associations have no owner it is necessary to identify the key Office Holder/s that is/are Senior managing Officials who make/s, or participates in making, decisions that affect the whole, or a substantial part, of the business of the client or who has the capacity to affect significantly the financial standing of the client. This for example may be the **Pastor, Treasurer, Secretary, Chairperson** or other Official that can exercise day to day authority in relation to financial matters of the organisation, whether or not they are a signatory to the account.

The definition of 'control' includes whether the control is exerted by means of constitutions, trusts, agreements, arrangements, understandings or practices and whether or not the individual has control based on legal or equitable rights. It includes where an individual can exercise control through making decisions about financial and operating policies.
